

Summary of Free Will writing services

Parkinson's UK has partnered with two Will writing services. The National Free Wills Network (solicitor based Wills) and Farewill Ltd (online and telephone Wills).

The National Free Wills Network and Farewill Ltd. have control of and are responsible for preparing your Will, not Parkinson's UK.

Parkinson's UK recommends that you carry out your own independent research on the providers which we are partnered with, and other will writers, and only choose the services of the providers if you are satisfied with their quality of service.

There is no obligation to include a gift in your Will to Parkinson's UK to use either free Will service.

The National Free Wills Network and Farewill Ltd. will be acting only in your interests and on your instructions.

You will not be able to get a free Will from either The National Free Wills Network or Farewill Ltd. unless you agree to their Terms and Conditions.

Parkinson's UK reserves the right to pause or withdraw the Free Will Services.

Online Wills:

- Farewill online Will writing service is only available in England and Wales
- Once you have made your will through Farewill, they will provide Parkinson's UK with your name, address, date of birth and email. Together with the date the will was made, the voucher code used and if a gift to Parkinson's UK was included. They will also inform Parkinson's UK of whether you have given permission to be contacted by the charity by phone, email or via post. Telephone Wills:

- The Farewill telephone Will service is available in England (including Isles of Scilly and Isle of Wight), Wales, Scotland or Northern Ireland)
- Once you have made your Will through Farewill, they will provide Parkinson's UK with your name, address, date of birth and email. Together with the date the Will was made, the voucher code used and if a gift to Parkinson's UK was included. They will also let Parkinson's UK know whether you have given permission to be contacted by the charity by phone, email or via post. To use the Farewill Ltd. telephone Will service, you need to:

- Be 18 or over
- Be able to read the documents sent to you without assistance
- Require a document, capable for use as Will in England (including Isles of Scilly and Isle of Wight), Wales, Scotland or Northern Ireland
- Be a permanent resident in the United Kingdom

- The National Free Will Service is available across the UK
- To register to the National Free Wills Network we will require your contact details. We will then pass on your details to the National Free Wills Network who will contact you directly.
