
The Learning Pathway is easy to navigate. You can explore according to your knowledge and experience level and specific learning needs.


Click on the circular icons on the right-hand menu to look at different learning levels and resources that may be useful for you.

To be eligible for this module you must have been registered with the HCPC or NMC for at least 3 years and have at least 1 year's experience working in the area of practice that you want to independently prescribe within. The module aims to equip students with the theoretical knowledge and practical experience required to become a non-medical prescriber. At present these include the Nursing and Midwifery Council (NMC) approved programmes and the HCPC approved programme for podiatrists.

To be eligible for this module you must have been registered with the HCPC or NMC for at least 3 years and have at least 1 year's experience working in the area of practice that you want to independently prescribe within. The module aims to equip students with the theoretical knowledge and practical experience required to become a non-medical prescriber. At present these include the Nursing and Midwifery Council (NMC) approved programmes and the HCPC approved programme for podiatrists.

#### Learning outcomes

- Demonstrate a strong clinical, pharmacological and pharmaceutical evidence base by justifying rationales for best prescribing practice
- Critically apply knowledge of drug actions to prescribe safely, appropriately and cost effectively
- Appraise formulated solutions in complex situations, employing relevant legal and ethical frameworks
- Critically evaluate personal and professional accountability in relation to prescribing practice within contemporary public health policy, regulatory and quality frameworks
- Demonstrate technical mastery when conducting complex holistic assessment, and consultation with patients and carers, documenting appropriately
- Critically reflect on issues surrounding concordance, justifying prescribing options with regard to safety, cost, efficacy and patient choice
- · Communicate and engage with patients and carers in a professional and sensitive manner
- Exercise a critical awareness of autonomous practice within a multidisciplinary team.




